

### Licensing Conditions

#### Licence to Import for Sale in the Kingdom the Industrial Products Prescribed by The Royal Decree to be in Conformity with the Standard

By virtue of section 25 bis of the Industrial Product Standards Act B.E.2511 (1968), as amended by the Industrial Products Standards Act (No.7) B.E.2558 (2015), the Secretary-General of the Thai Industrial Standards Institute prescribed the conditions for holder of a licence to import for sale in the Kingdom the industrial products prescribed by the Royal Decree to be in conformity with the standard to follow.

The Thai Industrial Standards Institute, therefore, has notified the conditions for licensing to import the industrial products of **lighting and similar equipment : radio disturbance limits, Standard No. TIS 1955-2551(2008)** for sale in the kingdom.

shall comply as follows:


Ko. Procedure for controlling the quality of industrial products to comply with the standard:

1. Licensee shall arrange for the factory specified in the licence to follow the below activities.
  - 1.1 The factory shall be obtained post-licensing surveillance as scheduled according to the "Particular Requirements for Product Certification";
  - 1.2 There must be in place the quality control procedure according to the requirements of quality control system specified by the "Particular Requirements for Product Certification";
  - 1.3 All items required by the standard shall be controlled/inspected/tested; each item may be inspected by either licensee or the authorized person;
  - 1.4 There is at least the testing equipment listed in the "Particular Requirements for Product Certification". The equipment shall be used for testing regularly at the factory.
2. Licensee shall notify the Institute of any change of information from the previously given statement which may affect the quality of the licensed products.
3. Licensee shall notify the Institute of the quantity and import of the licensed products prior to importation.
4. Licensee shall record and maintain records of customers' complaints related to the quality of products including records of corrective actions taken, and shall readily provide copies to the Institute, upon request.

Kho. Licensee shall pay the expenses for the inspection of the manufacture of industrial products or for the inspection of the industrial products within 15 days from the notified date.

Where the Secretary-General of the Thai Industrial Standards Institute deems it necessary to amend or revise the licensing conditions, the Institute will inform licensee to acknowledge and accept to comply with the conditions.
